**Team Requirements for

# Team Requirements for Nomination

The number of teams that Associations may nominate per season is determined through four factors:

- Player Registrations
- Venue Availability & Capacity
- Referee Panel
- Coach Accreditation

**Player Registrations** will indicate the number of teams an association could potentially enter, however, the **Venue Capacity**, **Referee Panel** and **Coach Accreditation** requirements to support the number of teams nominated must also be satisfied. An association which submits a nomination that exceeds these requirements will have their number of teams reduced.

## Player Registrations

The number of Registered Juniors (excluding Under 10's) will determine the maximum number of teams an association may enter. The registration figures shall be based upon the number of **actively playing** junior registrations the association has at the release of nominations.

The limit for team nominations is set as follows:

1. Associations with less than 28 actively playing registered male players in the age group/s in which they wish to participate may not submit a team.  
Associations with less than 20 actively playing registered female players in the age group/s in which they wish to participate may not submit a team.
2. Associations with less than 150 actively playing registered male junior players may nominate a maximum of one (1) team per male age group.  
Associations with less than 150 actively playing registered female junior players may nominate a maximum of one (1) team per female age group.
3. Associations with more than 150 but less than 300 actively playing registered male junior players may nominate a maximum of two (2) teams in each male age group.  
Associations with more than 150 but less than 300 actively playing registered female junior players may nominate a maximum of two (2) teams in each female age group.
4. Associations with more than 300 but less than 450 actively playing registered male junior players may nominate a maximum of three (3) teams in each male age group.  
Associations with more than 300 but less than 450 actively playing registered female junior players may nominate a maximum of three (3) teams in each female age group.
5. Associations with more than 450 actively playing registered male junior players may nominate a maximum of four (4) teams in each male age group.  
Associations with more than 450 actively playing registered female junior players may nominate a maximum of four (4) teams in each female age group.

## *Team Exemptions*

Associations may apply for an exemption to nominate more than the specified number of teams their player registrations allow them. An association may only seek an exemption if they can meet the venue capacity, referee panel and coach accreditation requirements to support the additional team/s, and they must also believe the quality of players available will meet the standard necessary to compete.

Associations may apply for **one (1)** exemption per gender per age group, however, it is at BQ's sole discretion whether these will be granted. A full written request for any exemption is to be submitted by the association alongside their Official SQJBC Team Nomination.

## Venue Availability & Capacity

Each association must provide a **minimum 6 dates** (out of a possible 10) of venue availability for the season. Associations should however be striving to give the full 10 days of availability with as much capacity as possible.

Each date must have a **minimum of 4 timeslots** available with the aim of a minimum of 4 courts if possible.

Failure to provide sufficient venue capacity as per the above calculation will result in a reduction of nominated teams to a level that meets the requirement.

## Referee Panel

Associations are required to provide a complete list of their SQJBC referees to Basketball Queensland at the same time of submitting their team nomination.

All referees nominated will be placed onto the SQJBC Referee Panel. From this panel, BQ will advise each host association of the available referees for them to create a roster each weekend of competition.

Basketball Queensland will review each Association's referee panel to ensure it has the required referees to cover their nominated teams. When compiling their panel, Associations must refer to the ***SQJBC Referee Panel Criteria*** to ensure the standard and depth required to sufficiently support their nominated teams is being met.

**A minimum of two (2) referees per team must be submitted to the SQJBC Referee Panel when nominating teams.**

From this panel, each association must confirm that they have **at minimum one (1) referee per team per game** by 5:00pm on the Tuesday before each carnival weekend.

The minimum grade for each referee submitted to the Under 16 SQJBC Referee Panel must be Association Intermediate Referee.

Associations must only list referees on their panel who have confirmed they will be available to referee for them in the upcoming SQJBC season. Basketball Queensland may contact referees for verification purposes and resulting from this may revise an Association's panel. A referee can be listed on one Association's panel only.

All referees must be registered on the OwnUrGoal database.

If a panel provided by an Association is insufficient to support the number of teams they wish to nominate, Basketball Queensland will review and may reduce the number of teams until it is at a level that can meet the requirements needed.

## Coach Accreditation

Any Head Coach or Assistant Coach must have the following requirements in order to participate in the 2022-23 SQJBC season:

- Current Level 1 Club Coach Accreditation.
- Registered on the OwnUrGoal database.
- Hold a current Blue Card.
